1. This offer is based upon a contingency search. Therefore the Government does not pay a search fee unless a candidate is hired;
2. The Government will not be charged any administrative fees for reproduction, postage, research, telephone calls, drug screens, employment and educational verification and background checks;
3. **The following discounts for volume will be granted:**
 - a. **If the Government places a task order for five (5) to nine (9) positions of any type, the search fee will be reduced to 18% of the hired candidate's first year's salary.**
